MUNICIPAL VISSION

"Kamarhati Municipality will work for the improvement of physical and social infrastructure with due consideration for pro-poor, participatory and inclusive development based with equity and equality. It includes concern for environmental factors (in widest sense of the term covering the city etc.), introducing gender and child sensitive policies, provision for 'shelter for shelter less', primary and mass education facility especially for the children of economically weak and linguistic minority sections. This will enable the citizens across the sectors of the society to be healthy, knowledgeable and economically self-sufficient. The municipality aims to achieve its goals pollution-free environment, development of greenery and enhancement of overall beautification of through mobilization of local and other resources, efficiency, better citizen interface and organizational development."

Our municipality will work for next few years in various sectors as follows:

- First of all we are very glad to share it to all that after taking oath by this board on dated 20th May 2015, their first initiatives was that to give incentive same as State Govt. rule to the retired employees for the two months' salary from our own fund.
- > It is also to mentioned here that we are going to take the huge target for the national project such as
 - Atal Mission for Rejuvenation and Urban Transportation (AMRUT) for FY 2015-'16 to 18'-'19
 - Pradhan Mantri Abass Yojona (HFA) for FY '21-'22
 - Sachh Bharat Mission for 2nd Oct. 2019

Owr town has commenced with affordable inintiatives to reach the ultimate Goal as scheduled by the Mission directorate. It is a great opotunity for us that out of 127 nos. cities/town our town has included within 54 cities for the first phase development work.

- The componebts under AMRUT :
- Prime project is to increase the amenity value of cities by developing greenery and well maintained open spaces (e.g. parks). In this reference we are able to submitt the 4nos. project of park within our town and to reach the ultimate goal i.e. to develop the remaining parks to be included within this project under this tenure if fund flow is smooth and available.

Side by side our target will be extended greeneries, children park, Amusement Park, footpath, roadside beautification etc. is required to make the city as ideal.



 Secondly, our entire town needs to provide systimatically sewerage system by laying sewer line with a Sewarge Treatment Plant (STP). Due scarcity of land we are unable to provide this in our jurisdiction but neighboring municipality have agreed to share their land by which (as they are using our Water Treatment Plant) we can utilize the project for the aforesaid purpose.

- Thirdly, municipality's ultimate goal is to provide the drinking water as per guideline 24x7 with supply of 135 lpcd. So it is highly required U.G.R. for storing water and boosting station, also laying the pipeline for the remotest end.
- Another new initiative is Urban Transportation which is municipality never thinks to implement in their town i.e. very much challenging to us.
- Every project can success if the working head functioning properly and perfectly.
 So, the authority and employee of municipality is working together with advance technology with well training periodically.
- Pradhan Mantri Abass Yojona (HFA) the tenure is 7 years i.e. '2015-'16 to '21-'22. We have already completed 1019 nos. of dwelling unit under JNNURM but in this project the deficiency was to restrict for slum area only. The new project will covered the slum & non slum area/BPL/EWS can take the facility. In this project carpet area of DU is more which helps the people live comfotably by utilizing the fund. Our target is about 8000 benificiary can avail the project facility and our town to be free from RT/asbestos shed as well as dilapidated house.
- Sachh Bharat Mission: The mission of this project is to keep the city clean. Our town is nearest to the city, so rate of growth of population is high. So it creates multiple times of garbage, waste water etc. but disposal ground becomes narrow by covering year after year garbage layer. To overcome this problem by decresing quantum of garbage at any means. In this project Govt. allowed to provide compactor to the all ULB's to minimise the situation.

Another mission is to provide road side toilet at a difference of 2.0 km for men/women those are belongings working class. We express that our ULB will co-operate to accelerate the programme successfully. It is our confidence to provide latrine to every house hold within this project.

> National Urban Health Mission (NULM):

As per the Constitution (74th. Amendment) Act, 1992, urban poverty alleviation is a legitimate function of the Urban Local Bodies. To reduce poverty and vulnerability of the urban poor households by enabling them to access gainful self employment and skilled wage employment opportunities Kamarhati Municipality has undertaken a lead role for all issues and programmers concerning the urban poor through National Urban Livelihood Mission (NULM).

This Municipality already formed 450 Thrift and Credit Groups under the scheme SJSRY. Now those groups have been converted as SHG as per guidelines of NULM. We have completed ward level awareness programme and now starting process to form Area Level Federation (ALF) to strengthen the foundation of the scheme.

Immediate after completion of registration of ALF we will start discussion with Bankers and vocational training agencies so that the members of SHG may get Bank loan and vocational training for their earning as per norms of the scheme.
