## INSTRUCTION

### INSTRUCTION

1. Affix recent self-attested passport size photograph in the specific space of the Admit card.
2. Without Admit Card and Voter ID/ Aadhar Card he/she will not be allowed to enter in the examination centre.
3. Candidate should reach the venue 1 (One) hour before the schedule starting time.
4. Use Black Ball point pen only for filling up the OMR sheet.
5. No candidate should be allowed without Admit cards.
6. Calculators, Mobile Phones, Electronic Gadget or any other electronic devices are not allowed in the Examination hall. Any candidates found using or in possession of such device will be immediately disqualified.
7. Any candidates found guilty of any unfair practice during the examination will be immediately disqualified.
8. No Candidates shall be allowed to leave the hall before the end of examination tenure and should submit QP AND OMR before leaving the Examination Hall. Otherwise She/he will be disqualified.
9. All Questions in the booklets are objective type. For each question four possible answers are given, but only one is correct. Your task is to find out the correct answer and mark your choice in the OMR Sheet.
10. On the basis of the result of the Written Examination, candidates will be shortlisted in order of merit and shall be informed about the next procedure.
11. Admission to the Written Examination is purely provisional. If at any stage subsequent to issuance of the Admit Card, the candidate is found on verification by the Municipality to be ineligible for admission to the test; his candidature shall be cancelled without any further reference to him/her. A candidate furnishing incorrect or false particulars or suppressing material information, will be disqualified, and if appointed shall be liable for dismissal for service. Any sort of malpractice shall be severely dealt with. In case of any dispute, the decision of Municipality shall stand final.
12. No travelling allowance will be admissible.
13. The duration of Examination is of 1 hour.
14. There shall be no negative marking.
