**Subject: Clarification and Response Request Regarding Demolition Notice**

Dear Sir/Madam,

I am Md Gayasuddin, a resident of 30/1 Bhagwan Mondal Street. I received a demolition order dated August 24, 2024, instructing me to demolish my construction within 15 days. I have several queries and requests related to this notice and would appreciate your prompt response. Please find my concerns outlined below:

1. **Previous Complaint and Municipal Action:** On August 24, 2017, I submitted a complaint to the municipality regarding an illegal construction on the eastern side of my property. At that time, only the foundation work had started. I request an explanation as to why no action was taken on my complaint. I am submitting a copy of this complaint for your reference.
2. **Illegal Passage Registration:** My neighboring party has registered a 4ft passage on the eastern side as a municipal passage, which was previously my personal passage. The municipality has also carried out the mutation. Why did the municipality not verify the deed before mutation? Furthermore, why was it not checked against the master plan to ensure the 4ft passage was correctly represented?
3. **Board Meeting Decision Reference:** During the board meeting held on December 27, 2023, a demolition order was issued. I request a copy of the order and its reference number. Additionally, I was informed that the Ward No. 8 councilor would mediate between the parties, but this mediation did not occur.
4. **Adjacent Building Legality:** Buildings on both sides of my property were constructed before mine, and mutual agreements regarding a 2ft area were notarized and signed by all parties involved. I am submitting this agreement as evidence and request clarification on whether these buildings are legal. If they are deemed illegal, should they not also be demolished?
5. **Sanctioned Plan and Construction:** I have a sanctioned plan, which I showed during the board meeting. Although my construction was in accordance with this plan, I request the municipality to consider revising the plan and allow for any legal charges if applicable. Additionally, a 10ft area on the western side of my property was allegedly encroached upon by Mr. Parwez Ahmed, who bribed municipal employees for unauthorized passage and installed a gate. Why has no action been taken against this violation? Moreover, no other building in the vicinity appears to adhere to sanctioned plans. Will the municipality take action against these as well?
6. **Property Tax Discrepancies:** My quarterly property tax has increased from ₹45 to ₹150, while neighboring properties have not seen a similar increase. I request an explanation for this discrepancy.
7. **Engineer and Councilor's Statement:** Following the board meeting, the Ward No. 8 councilor and an engineer visited my property and confirmed that my neighbor's construction was illegal. Despite this, my property is being targeted. I challenge the chairman to visit my property to verify the situation and reassess the demolition order based on the engineer's findings.
8. **Sanction Plan Approval:** My property, which is 2 kathas 7 chattaks 23sqft, was sanctioned for 75% of the area. Is there a specific reason for this sanction, especially considering the land's agricultural status or potential use?

In light of the above points, I request a detailed response. If my queries are not addressed satisfactorily, I will be compelled to file a case in the High Court and hold the chairman and municipality accountable. I am well aware of the extent of illegal constructions within Kamarhati Municipality and expect adherence to rules and regulations uniformly.

Thank you for your attention to this matter. I look forward to your prompt response.

**Subject: Complaint Against Illegal and Unauthorized Construction at 41/3 Bhagwan Mandal Street**

Respected Sir,

I, Md Gayasuddin, a senior citizen of 71 years, have been facing significant issues regarding illegal construction by Mrs. Qaimunisha W/O Haidar Ali at 41/3 Bhagwan Mandal Street, P.O. Ariadaha, Holding No. 867, Ward No. 8, P.O. Kamarhati, P.S. Belghoria, Kolkata-700057. Despite numerous efforts to resolve this issue through various legal channels, there has been no satisfactory resolution to date.

1. I filed a case under Section 144(2) of the Criminal Procedure Code (C.R.P.C.) concerning this illegal construction (M.P. No. 3151/2017). The order was communicated to the Officer-in-Charge of Belghoria Police Station and the Chairman of Kamarhati Municipality.
2. Additionally, I filed a suit (T.S. No. I.S. 323/2017) before the 4th Court, Junior Division, at Sealdah, seeking a restraining order against Ms. Qaimunisha to prevent her from opening any windows or making further illegal constructions. The court granted this restraining order.
3. I have also lodged several General Diary Entries (G.D.E.) against Ms. Qaimunisha and her associates.
4. Unfortunately, Ms. Qaimunisha and her associates have been uncooperative, continuing with their illegal activities despite these legal measures.
5. I respectfully request your intervention to expedite the demolition of Ms. Qaimunisha's illegal construction at the aforementioned address.

I have previously addressed my concerns to the Municipal Chairman, local Councilor, and MLA, and have sought the intervention of various officials, including the Chief Minister Mamata Banerjee and Mayor Firhad Hakim. However, my efforts have yet to yield a satisfactory outcome. Despite the Kolkata High Court's directive to the Kamarhati Municipality to resolve this issue, no effective action has been taken so far.

Given these circumstances, I appeal to you to review my complaint sympathetically and take immediate action to address this matter. The unauthorized construction has violated municipal laws and adversely affected my property by encroaching upon it.


## Sub: Demolition Order

Dear Chairman,

My name is Md Gayasuddin, and I am a resident of 30/1 Bhagawan Mondal Street. As a senior citizen, I am writing to bring to your attention a matter concerning ongoing legal proceedings regarding my property.

As you may recall, my case with Mrs. Qyamun Nisha is currently under consideration at the Calcutta High Court and the Barrack Civil Court. Three months ago, during a board meeting, both parties were summoned, including Ward No. 8 Councilor Mr. Deepangshu Ghosal. It was assured to me that efforts would be made to resolve the matter amicably. However, despite assurances, no progress has been made.

I personally met with Mr. Ghosal at his party office, where he requested me to submit my demands for mediation in writing. I promptly complied with his request, detailing the situation. Unfortunately, since then, I have not received any response from his end. Despite his earlier commitment to resolve the matter swiftly, there has been a conspicuous silence, leading me to believe that he may have aligned himself with the opposing party.

For your information, my legal battle has been ongoing since 2017 in the High Court, and according to municipal reports, while my building has a sanctioned plan, construction has not commenced. On the



contrary, the opposing party has unlawfully registered and mutated a common passage as municipal passage, constructed a building adjacent to my boundary wall, and littered the common passage with waste from their windows.

I have built my structure within my designated area, unlike the illegal constructions surrounding me, which have been erected without sanctioned plans. I urge you to investigate the matter thoroughly, and if no resolution can be reached, I implore you to take action against all illegal constructions in the area, including those belonging to my adversary.

I kindly request your urgent intervention in this matter and urge you to find a swift and just solution. Your attention to this issue is greatly appreciated, and I eagerly await your prompt response.
