1. The Quotation must be accompanied with an EARNEST MONEY RECEIPT of Rs.50000.00 (Rupees Fifty Thousand only) deposited with the cashier of the Municipality on or before date of opening of Bid. Reserve amount Rs.1000000/-
2. The successful offers will have to pay the entire amount of license fees for the in advance within 15 days otherwise next higher bidder will be ask to deposited the highest bid amount.
3. That the successful offers will have to make arrangement for collection/removal and disposal of carcasses by his own at his own cost.
4. The disposal of the carcasses must be made only at the approval space, provided by the Municipality for the purpose within the Municipal trenching Ground. He should remove all the residual material from the trenching ground immediately after operation.
5. That the Licence will be liable for removal of all dead animals lying on the Municipal Roads/Lanes/By Lanes by his men free of all charges.
6. That the licence shall have to enter into an agreement with the Chairman of the Municipality covering all the terms and conditions of the License.
7. If highest bidder fails to deposit the money in time then his earnest money will be forfeited. Date of publication of Carcasses lease Tender.
